

DRAFT SPECIFIC AGREEMENT No. 3252/B2000.EEA.00XX
First Agreement, based on Framework Contract No xxxxxxxx

Between the European Community, represented by the European Environment Agency, which itself is represented for the purpose of this Agreement by Mr. Domingo Jiménez-Beltran, Executive Director, hereinafter referred to as "the Agency" of the one part, and

the company xxxxxxxxxxxxxxxxxxxx whose registered office is at xxxxxxxxxxxxxxxxxxxx represented by xxxxxxxxxxxxxxxxxxxx

hereinafter called "the Contractor" of the other part, it is agreed as follows :

Article 1: Preamble

- 1.1 On xxxxxxxx, the Agency and the Contractor signed Framework Contract No xxxxxxxx for the provision of layout services. This Specific Agreement is based on the Contractor's offer of xxxxxxxx made for the named framework contract. Once this Agreement has been signed by the contracting parties, it shall be governed by the said Framework Contract.
- 1.2 All clauses and provisions of the Framework Contract which are not amended or revoked by the provisions of this Specific Agreement shall automatically apply in full.

Article 2 : Subject

- 2.1 The Contractor hereby undertakes to deliver the Agency with the goods and services specified in Annex I under the terms and conditions set out in this Specific Agreement and its Annexes, which form an integral part of the said Agreement.

Article 3: Duration and place of performance

- 3.1 This Specific Agreement shall take effect from the date on which it is signed and shall terminate by the latest at xxxxxxxx.
- 3.2 The work shall be completed in accordance with the timetable set out in Annex I and within the period for which this Specific Agreement takes effect. Where the agreed work or any part of it is not completed within the period of this Specific Agreement the Agency shall not be obliged either to accept the results or to pay for it.

Article 4 : Prices

- 4.1 The Agency hereby undertakes to pay the Contractor up to a maximum of xxxxxxxx in consideration of the services provided in performance of this Specific Agreement. It is understood that this sum shall cover all expenses

incurred by the Contractor under this Specific Agreement, including all travel expenses.

- 4.2 The services provided shall be invoiced after performance and acceptance by the Agency.
- 4.3 Payments shall be made to account xxxxxxxxxxx held with xxxxxxxxx on presentation of an invoice detailing the amount of the fee and the amount of VAT (if applicable), within 60 calendar days of the date on which the invoice is received. Payment shall be deemed to have been effected on the day on which the Agency's account is debited.
